The adoption policy when for people adopting new pets.

- A. The Adoption Contract must be understood, fully filled out, and signed.
- B. The animal needs to have a rabies vaccination and be dewormed before it leaves the clinic.

This is a contract between Willow Creek Veterinary Services P.C. (WCVS) and \_\_\_\_\_ (adopter) who is fully identified below. The adopter wishes to adopt from WCVS the animal identified below. In consideration for the adoption fee, the adopter agrees to give WCVS the sum of \$ \_\_\_\_\_. WCVS agrees to transfer guardianship of the animal to the adopter, subject to the terms and conditions below, which the adopter by his/her signature below acknowledges that he/she has read and understands, specifically:

1. Under no circumstances will the animal be abandoned, sold, or given away.

- I will notify WCVS if the animal is lost or dies.
2. I agree to take the animal to a veterinarian for routine examination and immunization as recommended, including annual rabies vaccinations, and to provide immediate veterinary care for the animal in the even the animal becomes ill or is injured.
  3. I agree to provide the animal with proper food, fresh water, warm shelter and kind treatment at all times.
  4. I agree to comply with all state and local laws pertaining to guardianship of the animal including those laws requiring licensing of the animal. I agree to redeem the animal promptly if the animal is recovered by an animal control agency.
  5. I understand the responsibility, safety and risk of guardianship and agree to care for this animal for the remainder of its life. I agree that WCVS has made no guarantees or representations concerning the health, nature or personality of this animal. I understand it has been examined and is believed to be in good health, however no guarantees can be made.

I understand and agree that any breach of paragraphs 1-5 constitutes grounds for WCVS to rescind this contract, in which case guardianship of the animal will revert to WCVS. I agree to assume all risk and responsibility of guardianship of the animal once the animal is in my possession. I agree to defend and indemnify WCVS against any and all claims for damages, including claims of property damage or personal injury allegedly caused by the animal arising out of the adoption and guardianship of the animal.
